#### **Get to Know Your Professor**

Hello! It's great to 'meet' you. Psychology is one of my passions that I've spent two decades studying and almost a decade teaching. I also adore traveling to find and explore new places, and thanks to CCSA, I've been lucky to combine the two. In Summer 2024, I took my first class to London to learn about psychopathology (mental illnesses) through the international lenses that the city and activities there offered. I'm excited to go back in Summer 2026 to take more students to these sites while also seeing more. I found that students appreciated and truly gained one-of-a-kind experiences through the places we went and the people we met. London has such a rich history and modern lessons to learn and gain from toward psychology, and I look forward to taking students like you with me as we explore them.

#### **Course Description**

This class explores how psychological abnormality and mental illness are defined using international criteria. Is there one way to define "the norm" or does that depend on values unique to a particular culture? By taking field trips in London to relevant sites, such as the Bethlem Museum of the Mind, Freud House Museum, and the Glenside Hospital Museum, and by discussing mental health issues and treatment with British mental health practitioners, students will gain valuable historical and contemporary perspectives on diagnostic psychology. Pre-med students and psychology majors, or those with an interest in social welfare issues, will find the experiential learning in this class uniquely valuable.

#### **Course Level and Credit Hours**

This course offers three hours of upper-division undergraduate credit as well as three hours of graduate credit.

# **Syllabus**

#### Prerequisite(s)

Prerequisites: Introductory Psychology (or equivalent), and one of the following: Social Psychology, Theories of Personality (or equivalent), or a Lifespan Development course (i.e., child, adolescent, or adult development). Students' admission to class can also be granted by permission of the instructor. If students believe they would be an appropriate addition to the class but have not met all the prerequisites, they are encouraged to email the instructor to discuss their admission to the course.

#### **Student Learning Outcomes**

Upon completion of all coursework with a passing grade and full participation in course activities, students shall be able to:

- A. Understand the roots of conceptualizations of psychopathology and how said background laid the foundation for modern clinical diagnoses.
- B. Discuss critically the current domains of abnormal behavior identified to be mental illnesses in various cultures.
- C. Integrate understanding of psychopathology into analysis of an individual who is displaying characteristics and/or traits indicative of abnormal behavior.
- D. Demonstrate informed knowledge of psychopathology and its history to understand the historical perspective of mental illness in the context of current attitudes and behaviors used in regard to these conditions.

#### **Required Readings and Materials**

This class will have assigned readings that are to be completed prior to arrival in London. These will include two (2) PowerPoint presentations along with articles describing a brief history of asylums in the US, along with resources related to modern UK and US-based mental health treatment. The latter of those will be the basis of the first assigned journal entry in the class. In addition, there are also two resources that students are recommended to have access to and to utilize on a regular basis. These are a link to the ICD 11 codes that is provided in this syllabus and an e-copy of the DSM-5 TR that students will be sent prior to class departure.

#### **Assignments and Grades**

- **1. Attendance/participation:** (50 points total)
- **2. Quizzes:** Students will complete six (6) guizzes (60 points possible)
- 3. **Journal:** (50 points possible with 10-point bonus opportunity)
- 4. **Term Paper:** Students' final assignment in the course will be to write a term paper of at least four (4) pages in which they select a fictional character from entertainment and identify traits the character displays that indicate psychopathology. This assignment will be due no later than ten (10) days following return to the US after the course in London. For graduate students enrolled in the course, the paper must be seven (7) pages in length. (100 points possible)
- 5. **Post-program Reflection**: This assignment will consist of at least two pages written and submitted to the course instructor no more than ten (10) days following return to the home campus after the course abroad ends. For graduate students, this paper must be at least four (4) pages in length. (50 points possible)
- 6. **Student-led presentation:** [Graduate students only]

#### **Attendance Policy**

Attendance is mandatory at all scheduled activities and class meetings, as well as field trip excursions. This includes any virtual meetings before and after the onsite experience. Repeated absences, including for ill health, will require documentation to be excused.

#### **Academic Integrity Policy**

It also means that, while studying abroad, students act as the best exemplars of American students. Students found guilty of an academic honesty violation (e.g., cheating or plagiarism) will receive a 0 on the assignment in question. More serious violations could also result in failing the course, a referral to the appropriate campus office of the member institution of CCSA participants, or both.

### **Physical Expectations**

The program requires walking 3-5 miles per day on uneven pavement in all kinds of weather and long periods of standing. Students must be able to carry their own bags and belongings.

#### **Disability Accommodation**
