#### **Get to Know Your Professor**

Professor Megan Pellegrino is the Director of Museum Studies at Walsh University. She also serves as the Director of the Hoover Historical Center, an on-campus history museum all about vacuums...you read that right, a museum about vacuums! This will be her third time leading students through global learning experiences in Europe. Fun fact: Professor Pellegrino spent a semester of her undergraduate studies at St. Mary's University, which is located just outside of London in Twickenham, and is excited to share her love for this amazing city with her students!

### **Course Description**

This immersive global learning course takes students to London's world-class museums and historic sites to explore how they interpret and present the history of Britain's home front during World War II. Through guided visits, discussions, and hands-on assignments, students will examine how exhibitions shape public understanding of wartime resilience, rationing, propaganda, and civilian experiences. Resources for this class include the Imperial War Museum, the Churchill War Rooms, historic walking tours, and the top-secret code-breaking facility at Bletchley Park. This course is ideal for students interested in museum studies, history, and public history, offering a unique opportunity to engage with the past in the very city that experienced it.

# **Syllabus**

### **Student Learning Outcomes**

Upon completion of all coursework with a passing grade and full participation in course activities, students shall be able to:

- 1. **Identify** key sites in London that played a role in Britain's home front during World War II and explain their historical significance through guided field visits to museums, memorials, and preserved wartime locations.
- 2. **Describe** how London's museums use artifacts, oral histories, and immersive exhibits to convey the experiences of civilians during the Blitz, rationing, and wartime propaganda.
- 3. **Contrast** different curatorial approaches to interpreting the home front by visiting multiple museums (e.g., Imperial War Museum, Churchill War Rooms) and assessing how they frame historical narratives for the public.
- 4. **Illustrate** the connections between London's built environment and wartime history by documenting remnants of the war—such as bomb damage, air raid shelters, and commemorative plaques—through self-directed exploration.
- 5. **Assess** the effectiveness of museum exhibitions and public history sites in engaging diverse audiences with the history of wartime Britain through structured reflections and group discussions with museum professionals.

#### **Assignments and Grades**

- Reflections on Museum and Site Visits 20% \*additional requirements for honors students
- Self-Directed Exploration Report of Wartime Remnants Found in London: Explore London looking for remnants of WWII and report what you find. 10% \*additional requirements for honors students
- Comparative Exhibit Analysis of Two Exhibitions: Pick two exhibitions or sites that we visit as a class and compare them. 30%
- Mini Exhibition Design: Design an exhibition focused on one aspect of the British home front during WWII, supported by museum interpretation best practices and historical sources. Present your exhibition in a video. \*Students will not actually create an exhibition, but will describe their concept with audience, interpretive methods, and historical objects. 30%
- Attendance and participation 10%
